



## Blue Ridge Juvenile Detention

Dear Parents and Guardians:

Blue Ridge Juvenile Detention is currently offering a limited visitation policy using our no-contact room. Visitation times will be available throughout the week and must be scheduled in advance. Visits will be limited to 45 minutes to allow time to sanitize the no-contact room after each use. The no-contact room will be sanitized after each resident and parent/legal guardian exits. Visitation will only be open to parents/step-parents, legal guardians, and grandparents at this time as the no-contact room can accommodate only two visitors. Each visitor will need to bring a picture ID and will be required to sign in. All other items must be left in your vehicle as lobby lockers will not be available for use at this time. You will be required to wear a mask to enter and exit the building and you may only remove it while in the non-contact visitation room. We will also be taking the temperature of each visitor. **Please do not attend if you have a fever, cough, or other symptoms of illness, or if you have had contact with someone who has tested positive for COVID-19 or if you have had contact with someone you suspect may be positive for COVID-19.**

When possible, we would prefer parents/legal guardians to schedule a standing time that is the same each week. Please arrive on time to utilize the entire visitation block. Visitation will end 45 minutes after the start of the visitation block. At this time, we will only offer one visitation block for each parent/legal guardian per week.

Parents/legal guardians who wish to schedule a visitation time should contact the appropriate case manager listed below. If you are unable to visit in person, please talk to them about the option of visiting your child by video (FaceTime, Zoom, Skype, etc.).
